April 11, 2019 @ 5:00 p.m.

Chairman Lowell Clawson called this meeting to order at 5:05 p.m.  
Board Members present were Chairman Lowell Clawson, Board member Wallace Godwin, Secretary/Treasurer Craig Davidson, Manager Sue Rigano, Clerk Kim Tompkins, Vice Chairman Gary Waldner and Attorney Mike Roberts connected via phone. Board member Gust Hatanelas was absent.

Public Comment: **None**

With no changes to the minutes of March 21, 2019, they **stand as written**.

Approval of Agenda: A motion was made by Wallace Godwin and seconded by Gary Waldner to accept the agenda of April 11, 2019. **Motion Passed**

Reports:

- (1) \$200,000.00 Cd has been purchased at Wyoming Community Bank in Riverton Wyoming. All paperwork has been signed and returned to the bank. Cd will mature March 28, 2020. Wyoming Community bank DOES NOT hold the CDs so a safety deposit box has been rented at Bank of Commerce.
- (2) The Recycle Center in Wamsutter is once again opened on Mondays, Wednesdays, and Fridays from 10AM – 4PM. A discussion ensued as to changing the days of the week we open for customer convenience. The board is thinking maybe 3 days in a row as opposed to every other day. Gary Waldner will ask around Wamsutter to get opinions.
- (3) Weather conditions impeded Tom Pilch from giving an update to the scales. We will put him back on the agenda for May 2019.
- (4) Haystack has paid their past due account in full as of March 28, 2019. The board has decided to keep them a CASH ONLY AT THE GATE.

Old Business:

- (1) It was discovered after the last board meeting; we would **NOT** be able to invest \$650,000.00 but would be able to invest \$350,000.00 in a new CD. Clerk Tompkins reported she had called Wells Fargo and never heard back as to the procedure for new accounts and signature cards. We will look elsewhere to invest this money.

New Business:


- (1) Manager Sue Rigano spoke with Copper France at BOC in Rawlins about purchasing a new CD. Mr. France quoted her in an email a rate of 1.90% APR 1.92% APY for 24 months investing \$350,000.00. A Motion was made by Craig Davidson and seconded by Wallace Godwin to purchase the CD at the Bank of Commerce. **Motion Passed**
- (2) A motion was made by Craig Davidson and seconded by Gary Waldner to have a **Budget Workshop on May 9, 2019** before our board meeting and try to arrange our **Budget meeting for June 13, 2019**. Clerk Tompkins will call Cuthbertson Accounting to arrange these meeting dates. **Motion passed.**
- (3) A motion was made by Wallace Godwin and seconded by Gary Waldner to change to our summer hours (10-5) effective April 15, 2019. A discussion ensued as to purchasing a sign for our gate at the transfer site in Bairoil stating the winter and summer dates and hours of operation. Summer hours will be April 15 – October 14th (10AM – 5 PM), Saturdays (9AM – 5PM). Winter hours will be Oct 15 – April 14 (10AM -4PM) Saturdays (9AM-4PM) **Motion Passed**
- (4) A motion was made by Craig Davidson and seconded by Wallace Godwin to pay bills Check # 15600 through Check # 15639 including all EFT's and debit card entries excluding Check # 15603 to Lowell Clawson, check # 15604 to Craig Davidson check # 15605 to Wallace Godwin, and check # 16607 to Gary Waldner. Total amount of \$231,111.96. **Motion passed.** A motion was made by Craig Davidson and seconded by Wallace Godwin to pay check # 15603 in the amount of \$42.80 to Lowell Clawson. **Motion passed. Lowell Clawson abstained due to pecuniary reasons.** A motion was made by Wallace Godwin and seconded by Gary Waldner to pay check # 15604 in the amount of \$42.80 to Craig Davidson. **Motion passed. Craig Davidson abstained due to pecuniary reasons.** A motion was made by Craig Davidson and seconded by Gary Waldner to pay check # 15605 in the amount of \$42.80 to Wallace Godwin. **Motion passed. Wallace Godwin abstained due to pecuniary reasons.** A motion was made by Wallace Godwin and seconded by Craig Davidson to pay check # 15607 in the amount of \$42.80 to Gary Waldner. **Motion passed. Gary Waldner abstained due to pecuniary reasons.**
