Regular Minutes

July 23, 2020

This meeting was a conference call due to COVID19

Chairman Lowell Clawson called this meeting to order at 5:01 p.m.

Members present at the Bairoil Office were Chairman Clawson, Secretary-Treasurer Gust Hatanelas and Clerk/Manager Sue Rigano.

Attending Via conference call were Seth Rauch and Attorney Mike Roberts.

Public Comment:

Clerk/Manager Sue Rigano shared with the board; we received a letter from the Sweetwater County Treasurer's Office stating the District has a negative balance due to Notice of Valuation Changes that were received from the State of Wyoming. We had to repay \$6,517.02 back to Sweetwater County Treasurers Office. This has been completed.

With no changes to the minutes of June 25, 2020 they stand as written.

A motion was made by Gust Hatanelas and seconded by Seth Rauch to accept the Amended Agenda for July 23, 2020. Motion passed.

Reports:

As you are aware Board Member Craig Davidson has passed away. Craig had served on our board for several years as a board member and as Chairman. Clerk/Manager Sue Rigano would like to do a memorial plaque for us and Craig's family. Sue will need to do some research as to how many years Craig served.

As of today, July 23, 2020 there has NOT been a repair person to fix the scales at the Landfill. Clerk/Manager Sue Rigano will contact Engineer Tom Pilch again to see what can be done.

The Finalized Budget for Fiscal year 2020/2021 has been signed and submitted.

Letter to Summit Line Construction: On 7-17-2020, Landfill Supervisor Jeff Evans reported Summit Line Construction had Cable in their dumpster that ended up in our pit, this happen (3) times in one week. Mr. Evans contacted Summit Line via telephone stating we are not permitted to accept cable, then he contacted Clerk/Manager Sue Rigano stating this issue.

Manager Rigano wrote a letter to summit Line stating we are not permitted to accept the cable, and if this happen again, Summit Line would not be allowed to use our Landfill. This letter was sent out by email and by regular mail.

Sue received an email and a phone call from Dan Young, with Summit Line apologizing for the issue, they do have a metal bin on site that gets hauled to Rawlins. They plan to be a long term tendent in Wamsutter and want to keep good relations.

New Business:




Pay Bills:
