Employee, Supervisor Jeff Evans Chairman Clawson, Secretary-Treasurer Dean Martin and Clerk/Manager Sue Rigano were present at the Bairoil Office. Hal Good was excused.

With no changes to the minutes of November 18, 2021, they stand as written.

Reports:

(3). The Audit for Fiscal Year 2020/2021 Sweetwater County Solid Waste District #2 is in progress. All the paperwork requested from us has been scanned to Auditor Donald Wiggins. Audit should be submitted by the end of December 2021.

(4). Christmas Closures:

The Landfill and Recycling will be "Closed" December 24<sup>th</sup> -Christmas and December 31<sup>st</sup>.-New Year's Eve.

The Bairoil Transfer Site will be "Closed" December 24<sup>th</sup> & 25<sup>th</sup> -Christmas. New Years Eve December 31<sup>st</sup> and January 1<sup>st</sup>. 2022.
