Public Comment:

No changes were necessary for the Minutes of August 18, 2022.

A motion was made by Hal Good and seconded by Seth Rauch to approve the agenda of September 15, 2022, as presented. Motion passed.

Reports:  
The Recycling Building in Wamsutter is open again two weeks ago, it was Closed due to illness.  
All employees are back to work.

Old Business:  
The bids for repair of the fence at the Landfill will remain on the table. Chairman Clawson stated both he and Landfill Supervisor Jeff Evans had spoken to Blake Wisroth, they were going to make some changes from the original bid, such as shorten the distance of the T posts add more drill stem 4 foot deep, he will re-submit the quote with the changes requested.

Clerk-Manger Sue Rigano stated she did re-advertise the Help Wanted ad after our meeting in August 18, 2022 as we had received NO applications. We did receive an application and the board approved hiring the applicant. The Help Wanted Ad was pulled. Chairman Clawson ask Supervisor Evans if he needed more help, Jeff replied no, they are good at the Landfill now.

**New Business:**

A motion was made by Hal Good and seconded by Seth Rauch to ratify the hiring of a full-time employee for the Landfill. Motion passed.

Chairman Clawson ask how the new employee was getting along learning the ropes and driving the trash truck. Supervisor Evans stated he road as a helper the first week of employment, but he has been driving this last week, doing good.

Clerk-Manager Sue Rigano stated she had been contacted about selling some or all of our old used dumpsters by a gentleman who was starting a recycling business in Torrington. They exchanged emails, he also called Supervisor Evans about dimensions of containers. Mr. Evezich will be coming to Bairoil next Wednesday to buy 2 dumpsters to see if they will work for him. Ms. Rigano did contact Chairman Clawson regarding this transaction as to what would be a fair price. Mr. Clawson suggested \$100.00 each. A discussion ensued regarding selling the old used dumpsters belonging to the Landfill. A motion was made by Seth Rauch and seconded by Hal Good to sell the dumpsters for \$100.00 each. Motion passed.

No executive session was needed.

A motion was made by Hal Good and seconded by Seth Rauch to pay bills check # 18039 thru check # 18096 including all Dc's and EFTs for the total amount of \$57,272.31. Motion passed.
