Chairman Clawson called this meeting to order at 5:02 p.m.

**Public Comment:**

Chairman Clawson stated he contacted Kevin-Ameri-Tech, regarding our new Freightliner Trash truck to raise the speed up to at least 70mph and see if they could add another or a bigger fuel tank. The truck now has a governor on it set at 65mph (safety issue running the interstate), the fuel tank is 50 gallons. Kevin will be checking this out for us.

With no changes necessary, the minutes of January 18, 2024, stand as written.

A motion was made by Dean Martin and seconded by Seth Rauch to approve the agenda for February 22, 2024. Motion passed.

**Reports:**

We received a letter from the Department of Revenue stating Sweetwater County Solid Waste Disposal District #2 is in Compliance for the year 2024.

The new Peterbilt-Hook Truck has been delivered to the Landfill on February 13, 2024.

Kevin and James stopped in Bairoil to do the paperwork on the new truck then proceeded to the Landfill, there they met with all Landfill employees going over the operations of the new truck. It is a very nice unit!

**Combining Cd's:**

We combined Cd #100481, Cd #11634 and Cd#12362. Cashing these (3) Cd's in we then purchased a new CD #100568, January 24, 2024 in the amount of \$2,130,682.41.

**Wyoming Solid Waste Recycling Association.**

On February 8, 2024 we received notification from Wyoming Solid Waste Recycling Association asking us to support them in their concerns with 24LSO 0183 as it conflicts with and contradicts several existing

laws regarding Solid Waste Disposal Districts. Chairman Clawson read the letter to all members present. Chairman Clawson responded by e-mail stating that our District #2 supports this action.

Old Business:

Discuss prices regarding the rentals for our roll offs.

Chairman Clawson and Clerk/Manager Sue Rigano discussed pricing to rent the 30-yard Rolloff containers we will be purchasing. A discussion ensued among members; Chairman Clawson stated research was done on what others were charging to rent Rolloff's.

**A motion was made by Dean Martin and seconded by Seth Rauch to approve the following prices.**

**A \$200.00 delivery fee in a 50-mile radius + mileage (at current rate allowed).**

**1<sup>st</sup>. month's rent \$250.00**

**\$50.00 per ton on C & D at our Landfill**

**\$65.00 per ton on household trash at our Landfill.**

**We currently charge \$270 to dump a roll off at our Landfill. Motion passed.**

**If we need to adjust our rates at some time in the future, we can do that.**

**\*\*A notice of these rates will be sent out to all our customers once we have received the new roll-offs.**

New Business:

Wyoming Machinery- Rich Whiteaker

Mr. Whiteaker explained this is a tool Cat is offering to customers who have newer equipment with a device for recording hours and service needed. Right now, we only have (2) machines that have a recording device. There is no charge for this service. A discussion ensued.

A motion was made by Dean Martin and seconded by Seth Rauch to give Clerk/Manager Sue Rigano permission to go on-line to authorize the use of this program. Motion passed,

No executive Session was needed.

Pay bills:

A motion was made by Seth Rauch and seconded by Dean Martin to pay bills Check #19081 through Check # 19134 including all Eft's and Dc's in the amount of \$361702.94. Motion passed.
