The Minutes of September 11,2025, stand as written.

A motion was made by Vice-Chairman Seth Rauch and seconded by Butch McFall to approve the agenda of October 23, 2025, as presented. Motion passed.

Reports:

There was a Meeting held at the Landfill 9-18-2025 regarding the Closure of our Vertical Expansion. Those attending were Engineer Tom Pilch, Clerk-Manager Sue Rigano, Landfill Supervisor Jeff Evans, Landfill Operator Ben Carter and employees from Western-EGI out of Rock Springs. Engineer Pilch went over some items that our employees need to fix, Supervisor Evans stated they have been working on those items requested by Tom Pilch.

A proposal was received from Western-EGI explaining the scope of the procedure to "Close" our Vertical Pit. This proposal was e-mailed to all Board Members to review.

On August 27, 2025, we had vandalism done to Zanes' work truck. The back door window on the driver's side had been broken. A police report was filed, and our insurance company was notified. The cost to replace the window was \$413.66. Landfill Supervisor Jeff Evans received a call from a victim's advocate asking if we wanted restitution?

Evans replied yes we do, the paperwork has been completed and sent in.
