**Pay Bills:**

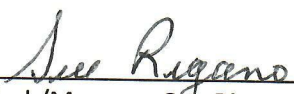
A motion was made by Seth Rauch and seconded by Dean Martin to pay bills Check # 20864 through Check # 20928
