

RESOLUTION NO. 2026-01

**A RESOLUTION OF THE BOARD OF DIRECTORS OF THE
SWEETWATER COUNTY SOLID WASTE DISPOSAL DISTRICT 2
ADOPTING THE BUDGET FOR THE FISCAL YEAR BEGINNING
JULY 1, 2026, AND ENDING JUNE 30, 2027.**

WHEREAS, the Sweetwater County Solid Waste Disposal District 2 is a duly constituted joint powers board formed pursuant to Wyo. Stat. § 16-1-101 et seq.; and

WHEREAS on May 14, 2026, the Board of Directors of the Sweetwater County Solid Waste Disposal District 2 prepared and submitted a proposed budget to the Sweetwater County Solid Waste Disposal District 2 Secretary/Treasurer and the Board of County Commissioners for Sweetwater County, who acknowledge receipt on May 20, 2026; and

WHEREAS, notice of a public hearing on said budget was posted at Bairoil Town Hall and the Districts offices beginning June 15, 2026; and

WHEREAS, a public hearing was held on the 25th of June 2026, at 5:00 p.m. at which time all interested parties were given an opportunity to be heard on the proposed budget; and

WHEREAS, the proposed budget document accurately reflects the revenues, expenditures, and cash reserves necessary for the operation of the district for the upcoming fiscal year;

NOW, THEREFORE, BE IT RESOLVED by the governing body of the Board of Directors of the Sweetwater County Solid Waste Disposal District 2 that:

Section 1: Adoption of Budget. The budget document titled "Sweetwater County Solid Waste District #2 Final Budget"—which has been prepared and submitted on the official Wyoming Department of Audit form—is hereby approved, adopted, and established as the official budget for the Sweetwater County Solid Waste Disposal District 2 for the fiscal year beginning July 1, 2026 and ending June 30, 2027.

Section 2: Appropriation of Funds. The total sum of \$3,094,250 is hereby appropriated from the district's revenues reserves and balances to defray the expenses and liabilities of the district for the fiscal year.

Section 3: Filing and Certification. A certified copy of this resolution and the adopted budget shall be filed in the office of the Sweetwater County Commissioners, and the adopted budget has been submitted electronically to the Wyoming Department of Audit.
